FAMILY REFERRAL PROGRAM POLICIES

Our research continues to show that most families discover BC Christian Academy through word of mouth. We are truly grateful that our growth and impact are fueled by families like yours — families who generously share their positive experiences at BCCA with friends, relatives, and colleagues.

You are BCCA's best ambassadors, and we want to thank you for your support in helping us grow our school community. As a token of our appreciation, BCCA is offering a \$350 tuition credit to both current and newly referred families. Here's how it works:

Tuition Referral Incentive Guidelines:

- 1. Only currently enrolled BCCA families are eligible to receive the \$350 tuition credit.
- 2. The **new family must enrol and pay full tuition and fees** to qualify.
- 3. Referrals to Kids Club are included in this program; however, the tuition credit applies **only if the new student enrols in Kindergarten or higher.**
- 4. This program does **not** apply to education agents whose children do not attend BCCA.
- 5.All new students **must complete** the formal admissions process.
- 6. There is **no limit** to the number of families you can refer each qualified referral earns you an additional \$350 credit.
- 7. The referred student must remain at BCCA for **at least one full school year (10 months)**. The tuition credit will be applied to your account for the **following school year.**
- 8. The credit is \$350 per referred family, not per student.
- 9. Referring families may choose to share part or all of their credit with the new family if they wish.
